Inauguration of Ageas Chair ' Insurance Analytics ' on the 7th of October 2019

Ageas continues its intense collaboration with the Leuven actuarial research group over the next 4 years through a sponsored insurance analytics chair. Holders of the chair are Prof. Katrien Antonio and Prof. Bart Baesens, who will stimulate a further cross-fertilisation between actuarial and data mining. The Chair allows fundamental and applied research to be built around the use of analytics for insurers. Publications from the first term of the chair covered insurance pricing through machine learning techniques, fraud detection with relational data and the use of regularization in predictive models with different types of risk factors (with accompanying R package).



Doctoral promotions






Invitation year event ALUMNI & FRIENDS
